

EDMANIA FESTIVAL - FESTIVAL RULES

The organizer of the EDMANIA festival reserves the right to change the program, the place and the date of the festival due to a force majeure or an official ban. The money received for sold tickets will not be refunded.

The entry to the festival is allowed to people over the age of 18. Visitors under the age of 18 may come to the festival if they are accompanied by a person over the age of 18; they will be marked by a special band. Minimum age is 16.

The following is forbidden at the EDMANIA festival:

- to bring glass containers (including bottles, cans), film cameras, weapons (firearms, gas weapons, thrusting and cutting weapons, knives), dangerous objects, pyrotechnic articles, explosive and ignitable substances.
- to bring your own drinks and food.
- to bring and use toxic, narcotic, addictive and psychotropic substances prohibited by Slovakia's legislation.
- to enter with dogs and other animals, except assistance dogs of visually impaired people.
- to distribute or place any advertising materials and promotional materials at the site or to perform other marketing activities without the organizer's permission.
- photographing and production of audio and visual recordings using professional technology during the festival without prior agreement with the organizer. (Only pre-accredited photographers are allowed to photograph using professional cameras. Participants are only allowed to use non-professional automatic cameras - compact cameras that cannot be used with an external flash.)
- to use of a GoPro stick and selfie
- to climb up or climb over built structures of the equipment in the area of the event, mainly on tents, fences, walls, barriers, lighting equipment, camera stands, poles/columns of any kinds, roofs and other constructions.
- to overcome fences, walls and scruples
- to bring objects or fluids to venue or camping site outside dedicated checkpoints
- to throw foreign objects or fluids on the production area or other festival visitors.
- to lay aside loosely glass objects or other objects that endanger the safety of other visitors
- to enter the festival site in cars, on motorcycles, bicycles, roller skates, scooters, etc.
- to bring suitcases, big bags, backpacks and umbrellas

At the EDMANIA festival, the participants are obliged to:

- adhere to the Festival Rules, follow the instructions of the festival organizer or persons authorized by him, such as the police, fire brigade, rescue service, and comply with legal norms of the Slovak Republic.
- suffer a security screening at the entry to the site, performed by the security service, even if special technological means are used. The screening also covers the backpacks being brought in and the visitor is obliged to enable a check of the individual objects being brought in. If the participant refuses the security screening, he/she will not be allowed to enter the festival site.
- he/she expressly agrees to the gratuitous use of a film recording, photographic recording, audio recording or other recording that the organizer or the persons authorized by him have made during the event
- identify himself/herself by means of the identification band that he/she has received in exchange for the ticket.
- wear the identification band firmly put on and not damaged on the wrist for the entire duration of the stay at the festival site and always submit the identification band for a check at the request of the organizer or security service. If it is discovered during the check that the participant does not own the band, he/she will need to buy the identification band or leave the festival site immediately. After taking off the identification band from the hand, the band becomes invalid! It is also invalidated by additional adjustments made to it. The identification band is a token of value, its forgery and altering is forbidden and is considered a crime.
- maintain cleanliness and order, avoid behavior that threatens the health and property of participants and performers, adhere to the general principles of good behavior.
- put waste into containers designated for this purpose.
- notify the organizer of a detected damage that may cause the health of persons or property.
- in case of an injury (accident) or another extraordinary event at the festival site, immediately notify the organizer of the festival through authorized persons.
- move around the premises of the festival site, in one's own interest, with care and avoid injury. Only move on premises designated for visitors, for example, by a fence, barriers, and the like. Any violation or disregard of the designated premises is considered a gross violation of the Festival Rules.
- adhere to the command and information boards located at the festival site.
- if an evacuation of the festival is announced, follow the instructions of the authorized persons directing the evacuation.
- adhere to the festival participation conditions, follow the instructions of the organizer or persons authorized by him and comply with legal norms of the Slovak Republic.
- leave festival venue except of festival program

ADMISSION to the EDMANIA FESTIVAL

- The two-day ticket is valid on both days.

- The one-day ticket is valid on the day of the program it has been used for, and it is valid until 6 am. On second festival day visitors who are leaving venue and want to come back will be marked with return ticket. Upon return to the venue visitor must identify himself with this return ticket.

Example 1: A visitor comes to the site with a one-day ticket on the first day of the programme at 11 pm. The ticket is valid until 6 am of the next calendar day. If he wants to get admission to the festival again on the next day, he has to buy another one-day ticket.

Example 2: A visitor comes to the site with a one-day ticket on the first day of the programme at 00.01 am. The ticket is valid until 6 am of the same calendar day. If the person wants to get admission to the festival again on the next day, he has to buy another one-day ticket.

ISIC / ITIC / EURO<26 discount

- ISIC / ITIC / EURO<26 is applicable on two day tickets which are sold via Partymenu.eu. Until 30.4.2018 we provide 15% discount and since that day until the end of online presale discount will be 10%. Discount is applicable only once on one card and is valid only for electronic tickets (PDF). Sale is possible only with debit / credit card. Ticket bought with this discount is valid only with ISIC / ITIC / EURO<26 card which has to be shown by holder upon arrival at the venue. Ticket is fixed with name and valid only with card with which it was bought. Visitor must show this card upon arrival.

CAMP SITES

- camp site TENT INN is opened from 22.6.2018 12:00 until 24.6.2018 12:00.
- camp site Ostrov / Island is opened from 21.6.2018 12:00 until 24.6.2018 20:00.
- It is prohibited to start a fire, to use cookers with open fire and grills in the camp sites.
- it is prohibited to smoke in camp sites outside dedicated areas
- visitor must behave responsibly so that he does not restrict or threaten any other visitor
- It is allowed to bring your own food and drinks in reasonable quantities for your own consumption to the camp site
- visitor is obliged to follow instructions of security guide and authorized persons who will be picked by organizer
- visitor can stay in camp site during whole festival weekend (opening hours above)
- no other person can visit camp site – only holders of valid vouchers for camping and two-day ticket holders.
- visitors can use toilets, showers, sanitary provided by organizer. Visitor is obliged to adhere principles of hygiene.

RULES of the EDMANIA festival:

The participant of the EDMANIA festival:

- participates in the festival exclusively on his own responsibility.
- must act considerately to other participants so as not to cause injury or damage to property to himself/herself or to others by his/her behavior.

- takes due note of the fact that without the identification band or in the event of a violation of other conditions for the participation in the festival, he/she loses the right to enter the site.
- is liable for any damage caused to the festival site equipment or to the property of other visitors (the damages will be enforced according to applicable Slovak legislation).
- agrees to the production of photographs, audio and video recordings of his/her person for artistic, news-related, advertising and promotional purposes, without claiming a remuneration for this.
- will be handed over to the Police of the Slovak Republic if he/she has seriously violated the conditions for the participation in the festival and if he/she is suspected of having committed a crime according to applicable legislation of the Slovak Republic.
- if he/she sees that someone needs medical treatment or help, he/she will immediately contact the medical service or the organizers of the festival.
- minor participants are the responsibility of their legal representatives or persons supervising minor visitors.

The organizer of the EDMANIA festival is entitled:

- to take out a festival participant out with the help of the security service from the site in the case of a violation of the Festival Rules or if he considers the participant's conduct to be disorderly.
- to give the festival participants instructions necessary for a smooth course of the festival, for the protection of health and for the protection of property.
- to perform a check of persons and their luggage at the entry to the festival site by means of the security service.
- to request damages from a participant for deliberate damaging or contamination of the equipment and facilities of the festival site or damage caused by a failure to observe the Festival Rules.
- to perform inspections in the field of fire protection.
- to change the program of the festival in the case of unexpected events (weather conditions, performers' health, accidents etc.), including a premature termination of the festival.
- to change the Festival Rules if necessary.
- the festival organizer is not responsible for damage to the property or health of the festival participants unless the damage is caused by a violation of legislation on the part of the organizer and directly related to the violation.
- in addition to the organizer of the festival, the security service is authorized to supervise compliance with and observance of the Festival Rules.
- first aid points are available at the site for the provision of first aid in cases of injuries and sicknesses.
